### Questions arising

Q Any action re the parking problems at the weekend?

A It was explained that football were the main users as a result of the new 3g facility. Explained that the Junior section had been told they couldn't increase the number of teams they have as the centre was at full capacity at the weekend. Extending the car park has been explored and presented to Basildon Council, but at present the £75k cost to extend is beyond WBCA financially.

Members commented that the centre was warm and looking well maintained. DM explained the maintenance contracts we have with ABEC and Heatech for the plant room. Trustees are hopeful that, as both boilers have now been rebuilt, the cost of maintenance will decrease.. This led to discussion that the charity is responsible for making enough funds to pay for all maintenance of the site.

Member A Haigh, Chair of HFFC Seniors, asked if more hooks could be fitted to changing rooms. Trustees will investigate the possibilities.

## **Financial Report**

➤ MN gave a briefing on the end year accounts (to 31 March 2019) for WBCA Ltd and WBCS Ltd. Performance is summarized thus:-

Comment WBCA - the in-year performance was very good at a profit of £ 43,220. The negative result is due to spending from reserves on projects of circa £ 45,000 and the need to depreciate new plant and equipment.
